# 006/25 Agenda Items:

i. Flooding: recent flooding at The Conifers occurred because of an error with the penstock gate which resulted in it not closing down. The pumps had tripped and as there wasn't any telemetry in place, the alarm was not raised. New telemetry has now been installed so that Yorkshire Water will be alerted to any future problems with the pumps and can respond quickly. The village has a combined drainage system though new developments are being built whereby surface water is being retained in storage tanks during the day and pumped out overnight. Yorkshire Water is currently building a water storage tank behind the Church.
