25/00442/FUL Two storey side extension to existing brewhouse to form new storage area (Use Class B8), brewery shop (Use Class E) and tap room (Sui Generis) with associated refuse store, boundary treatment and parking - Pivovar Ltd, Pivovar Station Yard, York road, Elvington

047/25 Highways, Paths and Verges:

i. Verges - a date has not been received from Morrisons Utilities as to when they will return to finish repairs to the verge.

ii. HGVs - Cllrs Laverack and Lloyd attended the YLCA York Branch meeting. Cllr Ravilious, Executive Member for Transport, was in attendance. Cllr Laverack asked about the disproportionate number of HGVs passing through Elvington which is a probable cause of the road collapsing. Cllr Ravilious will look into this.

Cycle Path - Sustrans has previously done a lot of work on creating a cycle path from Elvington/Wheldrake to Heslington. It is understood there are 2 parcels of land that rights to cross are still required.

Buses - the X36 service is the most heavily subsidised service. It was pointed out that a limited evening bus service would be welcomed by other communities in the area. This is to be followed up and the message reinforced.

Speeding issues - have been raised by parents. Concerns should be submitted to CYC. Cllr Laverack will contact the PSO for Elvington.

048/25 Legacy Project - there has been some progress. Cllrs Risker and Lloyd will apply for some Lottery Funding. Volunteers will be required to help with collecting and inputting data.
